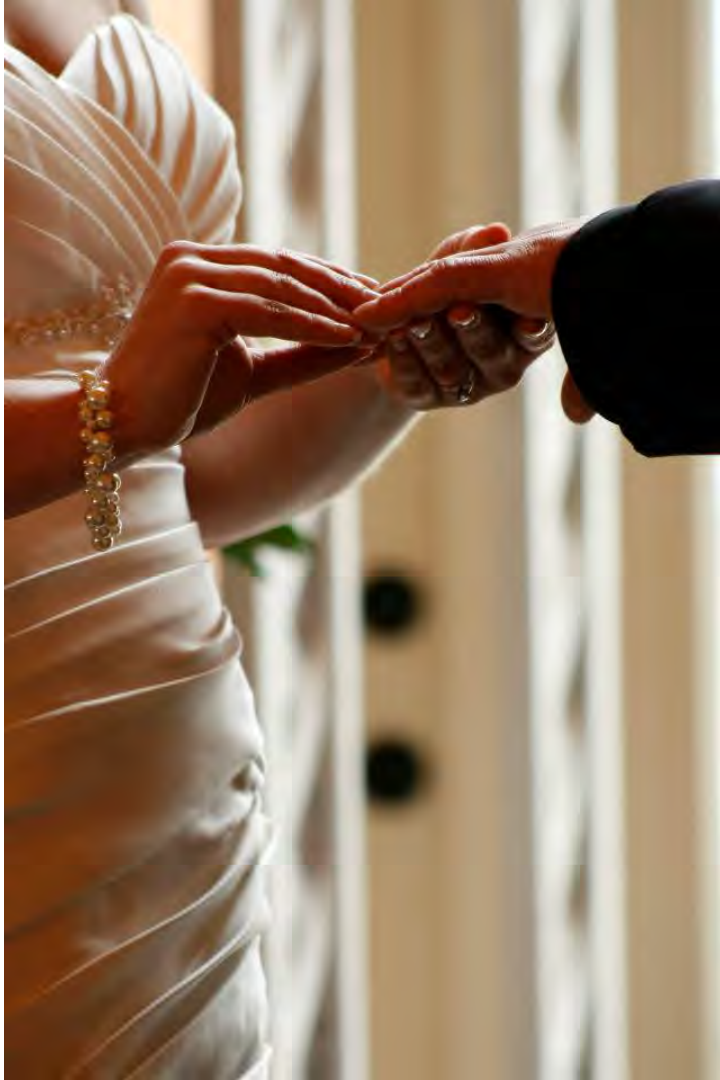

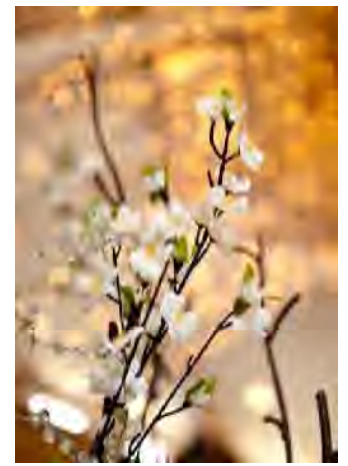
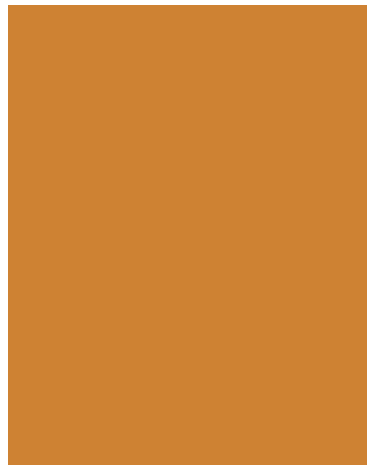

bar service

The Clubhouse at Lora Bay is pleased to offer cocktail servers and bartenders to look after you and your guests' every need. Our main bar is located in the Dining Room and additional satellite bars can be set up for your convenience. A set up charge may apply.

We offer 2 types of refreshment service for special events:

Host bar – a projected budget will be prepared based on your estimated guest count and approximate drinks per person. During the event, a master tab will be set up and all refreshments will be invoiced to you based on consumption. Bar selections are customized by you.

Cash bar – each guest will be responsible for the payment of their own refreshments. Bar selections and prices are set by Lora Bay.

Lora Bay is responsible for all sales and service of alcohol as governed by the liquor laws of Ontario. All liquor served must be purchased under our license at prices determined by management. All serving staff is smart serve certified and reserve the right to limit the distribution of alcohol based on smart serve standards of service.





event contract

Deposits:

Upon confirmation of your event day, deposits will be required within the given deposit schedule. Cheque, credit card, and cash payments are acceptable. Returned cheques are subject to a \$25 reprocessing fee.

Deposit #1 - \$2,500 is required to secure a date. This initial deposit is non-refundable.

Deposit #2 - \$50% of the total budget is due 90 days from your event date based on estimated guest count.

Deposit #3 - The remaining balance of the budget is due 14 days from your event date.

Any additional consumption charges will be invoiced the day following the event (i.e. host bar tab) and a final invoice will be prepared.

All details pertaining to your event must be confirmed 2 weeks prior to the event date. We will prepare an itinerary of your day based on your wishes to ensure the seamless execution of your event.

Cancellation Policy:

Lora Bay must be notified in writing 30 days prior to the event date. If written notice is received within that 30 day period, the 2nd deposit will be refunded and you will receive a copy of the contract marked "cancelled". If cancellation occurs less than 30 days before the event, full prepayment will be retained.

Decor:

Additional decor must be pre-approved by management in accordance with municipal codes, fire ordinance rules and in-house standards.

Guaranteed Guest Count:

The number of attendees is required 14 days prior to your event. If the number is not received at this time, the number of guests on the event contract will be seen as the minimum guarantee. If the actual guest count on the day of the event is higher than the originally contracted number, the greater number will be applied.

Menu:

Your menu selections must be made no later than 30 days in advance of your event. All menu prices are subject to change; however, we do guarantee prices at 60 days. In the event that you would like to make a change to your menu, we must have a 14 day notice of the change and it must be approved in writing.

Non-performance:

We shall not be liable for the non-performance of the event contract when such non-performance is attributed to acts of God and other causes, whether described herein or not, which are beyond our reasonable control, preventing or interfering with our performance. In such event, we shall not be liable to the client for any damages, whether actual or consequential. Arrangements involving outdoor ceremonies and inclement weather must be made 24 hours prior to event time.

Music & Entertainment:

SOCAN is an organization that administers the communication and performing rights of the world's entire repertoire of copyright-protected music, when used in Canada. SOCAN ensures the music creator and publishers get paid for the communication and public performance of their music in Canada and therefore collect fees from individuals, businesses, and organizations that play music in public. The SOCAN fee is based on guest count.
